

Ad hoc announcement pursuant to Art. 53 LR

Ningbo Shanshan Co., Ltd.

**Announcement on the Progress of Exchangeable
Corporate Bonds Exchange and Equity Changes by
the Controlling Shareholders**

Important Notice:

- This equity change is due to the conversion of the 2022 exchangeable corporate bonds issued by Shanshan Group Co., Ltd. (the "Shanshan Group") to professional investors, which has led to a passive reduction in the shareholding ratio of Shanshan Group in Ningbo Shanshan Co., Ltd. (the "Company" or "Shanshan"). Shanshan Group is the controlling shareholder of the Company. This equity change does not trigger a tender offer.
- This equity change will not result in a change in the Company's control.

On February 13, 2025, the Company received a notice from its controlling shareholder, Shanshan Group, stating that in accordance with the relevant provisions of the "Proposal on the Consent of Bondholders of Partial Bond Exchange" approved at the 2025 First Bondholder Meeting of Shanshan Group's 2022 Non-

III. Other Related Explanations

The current equity change is mainly due to the passive decrease in the shareholding ratio of Shanshan Group caused by the exchangeable bond holders of Shanshan Group exchanged shares. It does not involve a tender offer and there is no violation of relevant regulations and commitments such as the Securities Law, the Administrative Measures on the Acquisition of Listed Companies, and the Rules of the Shanghai Stock Exchange for Listing and other relevant commitments

pledge account for Shanshan Group's 2022 non-public issuance of exchangeable corporate bonds to professional investors is 370,540,078 shares, corresponding to 128,514,447 shares, 74,930,136 shares, 103,549,225 shares, and 63,546,270 shares pledged for the first to fourth phase bonds, respectively. Due to litigation involving Shanshan Group, the above-mentioned shares have been frozen (judicial mark) by the Intermediate People's Court of Mianyang, Sichuan Province (the "Mianyang Court"). According to the Civil Ruling issued by the Mianyang Court ((2024) Chuan 07 Min Chu No. 41-10), the Mianyang Court agreed to convert the bonds at a price of RMB 8.67 per share, and the converted shares will be directly transferred to the bondholders in a frozen (judicial mark) state. After the transfer is completed, the freeze on the corresponding shares and dividends held by Shanshan Group will be lifted.

According to the resolution of the first bondholders' meeting in 2025 for the non-public issuance of exchangeable corporate bonds by Shanshan Group to professional investors in 2022, the holders of the first to fourth phase bonds have agreed to authorize the LC Securities Co., Ltd. to apply to the Mianyang Court for a price change of 370,540,078 shares of Shanshan held by the issuer marked by the judiciary through bondholder conversion. According to the ruling of the Mianyang Court, the trustee will promptly carry out the share exchange related matters in the above-mentioned pledge account for this bond, and the subsequent progress will be announced to investors in a timely manner. If all the shares in the pledged special account are converted into shares, the cumulative conversion ratio will reach 19.08%, and the shareholding ratio of Shanshan Group and its concerted action persons will decrease to 29.29%, which is not expected to cause a change in the Company's control.

The Company solemnly reminds investors that the designated media for information disclosure are China Securities Journal, Shanghai Securities Journal, Securities Daily, Securities Times, and the Shanghai Stock Exchange website (www.sse.com.cn). All information of the Company shall be subject to the relevant announcements published on the designated media mentioned above.
